Contract between Minneapolis Organizing Committee, National Gymanfa Ganu, 1999 and Côr Cymry Gogledd America.

The Minneapolis National Gymanfa Ganu agrees to pay Côr Cymry Gogledd America the sum of \$20,000 to perform at the Grand Concert of the 1999 Welsh National Gymanfa Ganu on Saturday, September 4th, 1999. The choir will also perform special music in the two Gymanfa Ganu sessions on Sunday September 5th. Côr Cymry Gogledd America has the sole responsibility for determining their repertoire for the performances and will coordinate with the appropriate Minneapolis Gymanfa Ganu organizing sub committees with respect to all performance logistics.

Issues relating to the recording and rights of the Grand Concert and Côr Cymry Gogledd America special music at the Gymanfa sessions, is not addressed in this contract but will be the subject of separate negotiations.
