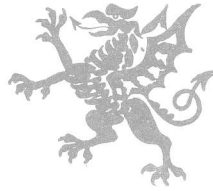

Dear Jack:

As chairman of the Endowment Committee, it is my suggestion to the Board of Trustees that I be authorized to draft a suitable letter which in final form would be sent to the members of the WNGGA for the purpose of obtaining contributions and bequests to the Endowment Fund.

If the subject is properly broached, such a letter might encourage people to make provision by will to leave a significant amount to the WNGGA. Such a letter could stress the fact that such bequests would be charitable bequests and thus would be exempt from federal and state estate taxes so far as the United States is concerned. So far as Canadians are concerned, I would think the same would be true. However, I would be sure to have the matter properly researched before any such letter went out.

In the event the Board decides that distribution of such a letter would be advisable, I would draft a proposed letter and circulate it among the Trustees and the officers, or just the officers, as the Board desires. The final letter would then incorporate any suggestions made.
