Dear Nancy:

A certificate of deposit which was a part of the assets held by me as Endowment Chairman became due. I thought it best to redeem the certificate and send it to you in your capacity as Endowment Chairman. I am enclosing a check made payable to the WNGGA for \$10,000. I would suggest that you purchase a short term certificate (preferably a six month) because of the status of interest rates at the present time. I have avoided locking in the assets into any long term because of the low interest rates prevailing at the present time. The rates seem to be going up and six months from now the rate structure might be high enough to justify longer term investments.

I have purchased all certificates as chairman of the Endowment Fund and used the I. D. number of the WNGGA which is 23-7304017.

I will now begin the orderly process of turning the savings account over to you and the proceeds of the present certificates in force as they mature. Keep in mind that when you open the savings account you should indicate that two signatures are required and send the signature card to Nelson Llewellyn for his signature. This will satisfy the Constitution.

The present amount available for distribution for scholarship grants is \$6,100.

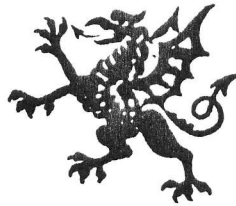
