

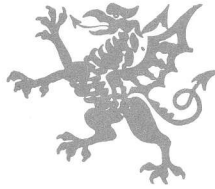

Dear Jack

I received my copy of your letter to Lew, and am at a loss to understand why you say you are perturbed by my shipping the tapes to you.

During our long telephone conversation, prior to the closing of the Golden Jubilee Bank account, you told me of pressures from the Board of Trustees, wanting the final financial statement and official check for remaining funds.

I explained to you then, the delay had been unavoidable because of outstanding checks still to be processed, one advertising account not then received, together with checks still being received from tape sales resulting from our ad. in Rinnae.

Your advice to me then, was to forward monies received after the account closing to Dave, and to let the Nat. Exec. handle future tape sales. To quote you, "they should go to Dave but he'll want me to handle them".

In order to be certain that this was the exec's decision, I requested instructions regarding the shipping of the remaining tapes, from Dave, Gwyneth and yourself. No-one replied, so I assumed your suggestion was acceptable to all concerned, and acted accordingly in order that the late tape requests be handled without further delay.

Please accept my apology if I have created problems, it seemed the wisest thing to do, and I believed I was carrying out your wishes.

We expected to see you yesterday, but were told you were not feeling well. Hope you will be fully recovered by the time we meet in Vancouver.

Dear Jack:

Your letter of July 21st was received earlier this week, and I must confess that it caused me some concern.
