SUBJECT: Folk Song Book

The Folk Song Book material is now ready for the printer, in fact it is now in the hands of the printer.

The Song Book Committee met recently to review several quotes and determined that the best quote so far as quality, service and storage availability was concerned was the quote from The Seneca Printing in Franklin, PA.

Cost of the printing will be more than was anticipated. The directive to the committee by the board of trustees at the mid-year meeting in Windsor, Ontario last April was to have 5,000 books printed at a cost not to exceed \$10,000.00. The quote from Seneca was slightly over the amount budgeted for 5,000 copies. To print the 5,000 would have been approximately 50% higher than \$10,000.00. The printer (Seneca) has agreed to furnish 2,500 books for \$10,000.00. In order to stay within the budgeted amount the committee is asking your approval to proceed with the printing of 2,500.
