Because of unresolved copyright issues, important elements of the material gathered by Emlyn are not included here. The Census Records for Fochriw/Pentwyn, 1841-1891, have been transcribed and are available, as are photos of various Tithe and Ordnance Survey Plans. Also, there are two plans of Pentwyn Churchyard – the Sexton's plan and one made by the Manpower Services Commission. If you want these for your own private use, make contact by email. ## **Items from Fochriw Records Requiring Clear Guidance re. Copyright**

### **File 109 PentwynBurialRecordsbySurnamepdf**

Background Information (i) As Emlyn's wife was for sometime Churchwarden of Pentwyn Church, and (ii) as her father had been Churchwarden of the parish of Fochriw and Deri for 40-50 years, and (iii) her uncle had been Vicar of the parish, it seems likely that access to the parish registers held locally would be a simple matter. Emlyn made a card index of the 4,119 interments at Pentwyn, and this was used to make file 109 - an Excel Spreadsheet containing the parish register detail and additional information that could be described as 'local knowledge' re. deaths that occurred in Emlyn's lifetime.

I have spoken with Stephen Leach at the Representative Body of The Church in Wales re. Copyright and File 109, and his immediate reaction was 'No idea.' He mentioned that the Mormons copied and published parish register information just mentioning the source.

I would welcome guidance on the completion of the Creator, Owner and Copyright columns of the api.

Accompanying the records are two plans of the Churchyard made by Emlyn based on a very basic 'Sexton's Plan' and a plan made by the Manpower Services Commission working with unemployed young persons.. Unless otherwise directed, I intend to name Emlyn Evans as Creator (after Sexton) and Creator (after M.S.C), to place 'none' under 'Owner' and under 'Copyright.'

### **Files 102-108 Transcripts – in Excel – of the Census Records for Fochriw 1841, 1851, 1861, 1871, 1881, 1891**

I have recorded 'HM Government' in the Creator and Owner columns re. the above. Is this correct? I understand that these records are no longer copyright and so intend to record 'None' under 'Copyright,' unless you direct otherwise. [If the place where Emlyn obtained copies of the various Census records is of relevance, then treat it as though it was the Glamorgan Record Office, but I can't be sure of that.]

### **Files 113-118 Maps of Fochriw – Tithe Map, O.S. Plans - 1<sup>st</sup> Edition, 2nd Edition and the Revision surveyed in 1915**

I don't know where Emlyn obtained his copies of these maps. It might be easier, therefore, to say that they were obtained from the National Library. Under 'Creator' I have put HM Government. Please advise if correct or not and what is to be recorded under 'Owner' and 'Copyright.'
