	These 18th century properties have been linked for much of their history, and in 1773 were one property owned by Edward Bates. In 1784 it was the Greyhound Inn with Nathaniel Young as the licensee. The Bates family continued as owners until at least 1830 but by 1843 the owner was William Jenkins. The Greyhound continued here until in 1865 the name was used for an inn in Westgate; these premises subsequently became the Vale of Glamorgan Brewery owned by Lewis Jenkins. The malthouse was in what is now called the Wool Barn, with the cart shed and stables for six horses across Bear Lane. Lewis Jenkins, originally from Llantrisant, was actively involved in Cowbridge life. He was an alderman and was made a freeman of the borough in 1923. He and his family lived here for many years before moving to Graig House in Eastgate; he died in 1929 aged 94. In 1915 the property was leased to William Hancock, brewers of Cardiff, and sold to them in 1923. No 51 was used as the off licence and distribution centre for beers, and No 53 became a private residence. In the 1920/30s Tom David lived in No 53; he was a skilled thatcher and thatched Y Bwthyn Bach, the cottage presented to the then Princesses Elizabeth and Margaret by the people of Wales. By the 1960s, No 53 was the Vale of Glamorgan public house and No 51 the off-licence. The front of No 51 is now Gail Armytage's florists shop, with the rear and first floor the kitchen and hotel accommodation of the pub	Cowbridge Buildings & People – CRS 1999

The Off Licence was managed by Mr Joe Staien, the house being a private one, until lately being changed to the Vale of Glamorgan Hotel. I can remember Miss Mary Tutton living in the house and after her Mr Tom David, who came from a renowned thatching family and his widowed sister, Mrs. Jenkins. He it was who thatched the little cottage given to our dear Queen, when a little girl, and her sister Princess Margaret by the people of Wales. The thatch caught fire either on the way or when the cottage arrived in London and Tom went up to re-thatch it. He was proud to tell me that the Princesses went to see him at work every morning and when he left presented him with a photograph each." 1940s	'My grandfather Reginald Wager and his sister Pat were evacuated from the Medway area in Kent to Cowbridge. They were 8 and 5 years old and because they wanted to stay together were the last two to find a home. A widower called Mrs Jenkins agreed to take them both and they stayed with her for four years. Mrs Jenkins had a brother called Tom who was a thatcher and lodged with them. My grandfather recalls that he thatched a play cottage that belonged to Princess Elizabeth and Princess Margaret. My grandfather said he learned to swim in the river behind the Town Hall. He also used to go to church three times on a Sunday and sing in the choir. He recalls reading a 'Beano' comic whilst pumping the church organ! He remembers the school being at the top of a hill and the headmaster was called Mr Roberts.
