

The will of Mary Thomas, spinster of Cowbridge, dated 9th., September, 1720.

To Edward Thomas, son of Thomas Lewis of Laleston, gent, £5 to be paid within a year of her death.

To Elizabeth Thomas, daughter of Thomas William of the Golden Mile, deceased, £5 to be paid within a year after her death.

All the rest of the estate to her aunt, Maudlin Evers, as executrix.

Proved - 10th., December 1720.

In the Name of God Amen I Mary Thomas
of the Town of Cowbridge in the County of Glamorgan being
being sick in body but of sound and perfect Memory (thanks
be to Almighty God for the same) doo make and ordain this
my last will and Testament (Revoking and making void
all former wills & Testaments by me heretofore made or done
or caused to be made or done) in manner and form following
First I recommend my soul into the hands of Almighty
God who gave it me trusting through the meritorious
Death of our Saviour Jesus Christ to have full pardon and
remission of all my sins, and my body to be buried at
the discretion of my Executors hereafter named and as for
what temporall goods and Estates the Lord hath bestowed
upon me I dispose of as followeth, Item I order that my
funerall Expenses and debts be paid and discharged
Item I give devise and bequeath unto Edward Thomas son of
Thomas Lewis of Laleston gent five pounds sterling to be paid
to him by my Executors within one year after my decease I
give to Elizabeth Thomas daughter of Thomas William of the
Golden mine (deceased) five pounds sterling to be paid to her within
one year after my decease by my Executors, Lastly all other my
Goods Cattle and Estates moveable & immovable I give devise
and bequeath unto my well beloved Aunt Maudlin Evans
widow whom I doo here by Name and appoint to be
my whole and sole Executrix of this my last will and Testament
In witness whereof I have hereunto put my hande this Ninth
Day of September Anno Regni Regis Domini Nostri Georgii tertii Regis
magne Britannie & Septimo Annoq; Domini 1728
