## Hill House, Llanblethian

*Hill House* stands further down the hill from *The Cross*. It is worthy of mention in the RCAHM volume of farmhouses and cottages in Glamorgan, as a good example of a house with central stairs and which has the date - 1726 - inscribed on a wing of the present building. The oldest part has massive stone walls; the verandah is of Victorian date.

We are almost sure that this was one of the properties owned by Thomas Wilkins of Great House in the early eighteenth century, and after his death by his son Cann Wilkins. William Thomas, a land agent and property owner, lived there in 1775, when it was sold by him to Thomas Lewis of Cowbridge, together with the stable, barn and rickyard on the western side of the road (now converted into a separate house).

In 1791, Revd Robert Nicholl of Llanmaes bought the house (and Thomas Lewis's furniture in it), but after four years sold it on to Revd John Morgan, the vicar of Llanblethian. On his death, it passed to his widow, Mary, and then to a niece Ann Thomas, who lived in *Hill House* from 1824 to after 1840. Some of her letters, to Mrs Jones of Bath (formerly of *Crossways*) have been preserved, and give a picture of life in the village in the 1830s - vandalism linked to drinking at *The Picton*, buying a mare at St Mary Hill fair, the availability of coal from a depot at *The Golden Mile* inn, and in 1836 - "my house is full of workmen painting and papering, the walls had gone so shabby".

By 1851, *Hill House* was occupied by William Edmondes, together with his wife, sister-in-law and 3 servants. He was described in Hunt's Directory of 1848 as solicitor, Town Clerk, clerk to the Guardians of the Bridgend Union, and superintendent registrar. According to David Jones of Wallington, he shot himself in a house (now demolished) in Church Street, Cowbridge, in 1855, having embezzled £1200 from the Bridgend Union.

The next inhabitants were William Smyth, a lieutenant in the Third Iniskillin Guards, and his wife Ann (from Llandow) and daughter. Walter Smyth, their son, became a chemist in Merthyr Tydfil; his first wife died in childbirth in 1855, but he remarried Mary Annie Morgan of Llanblethian in 1866.

From 1870 to 1892 William Thomas and his wife Jane, from Merthyr, and 3 children lived here, having moved from *Cowbridge Town Mill*. William Thomas was a maltster and manure dealer, and his sons were in business with him. He owned the malthouse in Factory Road until it was taken over by Hancocks Brewery. Frank Wyatt, a faithful servant, used to drive the high-wheeled cart for hauling the barley to the malthouse. William Thomas died in 1892; his son, William Richard Thomas, who married Elizabeth Rogers (daughter of the Cowbridge ironmonger who had shot himself in 1882) took over the property.

On her husband's death in 1900, Elizabeth continued to live in *Hill House*, even after her remarriage, when she became Mrs Moon; she sold the house to Thomas Thomas of Red Farm Penllyn, who was building up his holdings in Llanblethian, in 1908. The tenants were George Morris and his wife, who had previously lived in *St Quintins*.

In 1914, Joseph Wm Hall had taken over; he was a hay dealer, and a Glamorgan magistrate; his wife was reputedly a member of the Bird's Custard family. In 1926, Francis William Crawshay lived here.

Present building perhaps 1850ish but wing dates from 1726 (carved stone shows date). Stables across road were part of Hill House land.

The house was visited by Carlyle in 1850 in the course of his writing the life of John Stirling (1806-44) – one of the world's first military commentators and correspondents. Stirling used to get news from the front to Llanblethian and analyse it here at Hill House. In the garden, top corner towards Mount Ida, is Carlyle's 'twmp' where Stirling used to stand to see the mail coach coming over Stalling Down.

Other inhabitants: Thomas a farmer and Rogers a brewer, Joseph Hall hay merchant – married a daughter of the Birds custard family. They met while drinking water in Llandrindod or Llanwrtyd.

'Mr Jonathan Morgan lived at Llanblethian in the old house which stood where Hill House now stands. He was I think a lawyer. There were anecdotes respecting him floating about the village in my childhood but I can only recall one: his telling Molly the servant maid (afterwards the wife of John the Shoemaker – Sion y Crydd) on the morning of all Fools' Day to go and milk the ducks. Molly got the pail out for the purpose!

His widow who was also dead long before my time was somewhat of a character. She fancied herself famous for making plain cake. Visitors called the day – the Nicholls of Ham – and the plain cake was brought out. "Take some of it Mrs Nicholl, it is very plain, there is neither cream nor currants in it", said good, delicate Mrs Jonathan Morgan, whose stomach repelled everything rich. "Oh" said Mrs Nicholl (whose taste was not quite so plain) "I shouldn't like it any the worse if there had been!".

- (iii) verandah is Victorian
