Eastfield House

Grade Il listed 1999 – 'Early 19th century house, featured on the tithe map. House: channelled and scribed stucco, slate roof, two storeys, 3 windows plus 2 set back. First floor of main block has three 16-paned horned sash windows. On ground floor, pedimented doorcase flanked by 12-pane hornless sashes. In 2-window block to right, two 16-pane horned sashes to each floor. Well preserved'.

Among the lands belonging to the Gwyn family of Llansannor was a three-acre field just to the east of the borough of Cowbridge, along the road leading to Stalling Down. In 1805, this field, known as Tair Erw Pen y Pentre, was sold to Isaiah Verity of Cowbridge, who soon afterwards built this pleasing Georgian house, with stables, on part of the field. Verity was a successful Cowbridge mercer; according to David Jones of Wallington, he made some of his money from dealing with smugglers, and when he refused to pay one called Banks for his smuggled tea and rum he became the butt of jokes and rhymes:

Verity, Verity, Vee, won't pay Banks for his smuggled tea. Verity, verity, Vum, pay the poor man for his smuggled rum.

When Isaiah died in 1838, he left the property to his son Abraham, a surgeon living in Bridgend, who let out the house to a series of professional men. These included John Bellingham, or Billingham, and William Wood, in the period between 1840 and 1850. Henry Rogers, an army captain born in Wexford, was recorded there in the 1851 census, and was followed in 1852 by a Mr Webbley.

An advert in the Bridgend Chronicle for December 1857 runs as follows: 'Eastfield House Commercial Academy. Mr George Rees, formerly master of schools in Swansea and Bath, is opening a school with boarders and day pupils (premises recently occupied by M. Barnett, French master of the Grammar School'. Whether that school actually opened is not known, but by 1861 it was once again a family residence - that of Thomas Williams, a commercial traveller born in Michaelston, with his wife, five children, father-in-law and a servant. It seems that the Williamses moved here from Eglwysilan, only the youngest, 10 month old, son being born in Llanblethian parish.

The Williamses did not stay long, for a deed of 1866 records the recent occupants as being Lewis Jenkins, maltster, preceded by Mr Daniel Ithiel Edwards, surgeon - an old friend of David Jones of Wallington.

Thereafter came stability in occupation. John Thomas, aged 49, who had been born in Ewenny, was recorded there in 1871, with his wife Mary and two servants. John Thomas was an auctioneer - papers of the time frequently record the sales organised by him - and in addition farmed 170 acres and employed seven men. The censuses of 1881 and 1891 also show him living in Eastfield House, though he was then described as a land agent. In 1881, also living there were a niece and two nephews - E T Alexander, an auctioneer, one of the 'founding fathers' of the firm Stephenson and Alexander, and W D Alexander, a farmer, who later in the same year married Mrs Lydia Harding of Cowbridge Town Mill.



After John Thomas died in 1893, there was again a rapid series of owners and occupiers; William Roberts, and then his widow Catherine, were there in 1896 and 1897, when it was sold to Alfred Myers, a railway agent of Islington. The following year Mary Rees took over, then Arthur Leyshon of Llantrisant in 1902 and John Evans of Trealaw in 1907. Later in 1907, the house was sold to the then tenant, Arthur S Evans.

Arthur Stephen Evans was one of the sons of S D Evans, the draper of 37-39 High St in Cowbridge. Arthur was one of the pioneers of motoring in the town. He initially took over his father's drapery business, but gradually developed his interest in transport, by first opening a cycle depot at no. 39 (by 1912), and then by 1914 running a motor garage at 4 High St (where there is now a car park for the Filco supermarket). This site was too narrow for effective use, as he hired out cars as well as selling and repairing them, and so A S Evans built the garage at the Bridge, and ran it successfully for many years. He died in 1958 aged 93.
