John's sister ANN DEERE married John Thomas of Garth & Bristol - a descendant of the Deeres of Wenvoe - at St. Athan in 1758.

They were two of the children of WILLIAM DEERE and his wife MARY ROBERTS of St. Athan. William Deere's will was proved 1740, and his widow later married Thomas Sweet at St. Athan in 1747.

#### JOHN DEERE and wife MARGARET REES were parents of Rev. Morgan Deere and others.

Rev. Morgan Deere and wife buried three children in little over a month at Llanilid in 1799, there must have been an epidemic of some sort. None of his 7 known children were baptised at Llanilid. From 1785 to 1789 Rev. Morgan Deere was rector of St. Georges, and in 1799 of Llanilid. He also appears on the web site of St. Brides-super-Ely as rector 1785.

## **REV. MORGAN DEERE**

He and his wife Mary Ann [nee **TUCK ?]** had lost three of their children in what appears to have been an epidemic Nov. - Dec. 1799, and these three are buried at Llanilid, but were not baptised there. They had four surviving children at the time of Rev. Morgan's death in 1821, Didmarton, Glos.

These were JOHN MORGAN RUDOLPH DEERE, JOSIAH EYLES DEERE, RICHARD TUCK DEERE and HARRIET ELIZABETH DEERE.

JOHN MORGAN RUDOLPH DEERE, Gentleman of Llanilid, son of Rev. Morgan Deere and Mary Anne, accused of assault [including wounding, but not malicious wounding] at Llanharan 12th March 1813, against William Morgan of Llangeler, Carmarthenshire. J.M.R.D. appears to have died at Clifton between June and August 1843, but enquiries have not found a burial there. He was one of three sons named in Rev. Morgan Deere's will, along with a sister Harriet Elizabeth Deere. John M. R. Deere was a solicitor of Cowbridge at the time of their father's death 1821 in Gloucestershire. From this, coupled with G. T. Clark's mention and the David Jones of Wallington notes I found at Cardiff Central Library, I believe he is the John Deere of Cowbridge said to have used a seal [3 buck's heads erased, not asses' heads per Clark] 1819 Cowbridge. A John Deere also appears on the Militia Lists of this time for Cowbridge.

John Morgan Rudolph Deere married SIDONE CLOTILDE DE MARIE DE TAYAC on 2nd May 1842 in All Souls, Saint Marylebone, London. There are a number of baptisms & deaths in London of possible descendants, some with French-sounding Christian names, but they were not married long before J. M. R. Deere died. Given his approx. age, it is possible he had been married before?

**JOSIAH EYLES DEERE**, son of Rev. Morgan Deere and Mary Anne. There is a cadet of this name, British Army, mentioned in records at British Library. He married MARIA SOPHIA GRIFFITHS on 7th November 1846 at St. Martin-in-the-Fields, Westminster. Haven't found anything definite on his burial, but there is a Joseph Eagles Deere buried 1847 at Medway, which may be a misprint in the Free BMD list.

HARRIET ELIZABETH DEERE daughter of Rev. Morgan Deere and Mary Anne. No further details found.

**RICHARD TUCK DEERE**, son of Rev. Morgan Deere and Mary Anne. He appears on the 1845 Electoral Rolls of Glamorgan and having lands at Llanillid and Waterstown, Glamorgan, and was then of Chippenham, Wiltshire. His wife's name was CHARLOTTE and they had two sons, JOHN MORGAN DEERE baptised 17 Nov., 1824 [died aged 79, Paddington, 1904?] at Southbroom St. James, Wiltshire, plus RICHARD TUCK HOPKINS DEERE, see below. Richard Tuck Deere [the father] died / was buried at Kensington between October and December 1863.

**JOHN MORGAN DEERE** [son of Richard Tuck Deere] and family in 1881 were living at 6 College Street, Islington.

John Morgan Deere was born in Devizes, Wilts. and was aged 57, a solicitor.

His wife Louisa A. Deere was aged 42 and born in Scotland.

Their 5 year old son ERNEST F. DEERE was aged 5 and born in Uxbridge, Middlesex.

The family were taking in boarders, of which there were five, plus a general servant.

JOHN MORGAN DEERE and family were living at 1 Durham Terace, Paddington, 1901 census. He was aged 76, a retired solicitor, born in Devizes, Wilts. His wife was Louisa A. Deere, aged 62, born Cromarty.

Their 26 year old unmarried son ERNEST F. DEERE was living with them, born Hammersmith London,

occupation clerk to cigarette makers. There is a baptism of Ernest Frederick Deere in Fulham in 1876, January to March

In 1901 the family were still taking in boarders.

**RICHARD TUCK HOPKINS DEERE/DEARE**, [son of Richard Tuck Deere] was born in Alworth, Wiltshire c. 1835.

MARRIAGE: RICHARD TUCK HOPKINS DEARE/DEERE married JANE ANN RUSSELL 21 September 1864 at St. John The Evangelist, London. The records of this church are held at Guildhall Library, Aldermanbury, London. EC2P 2EJ

Hammersmith records are held by the Hammersmith & Fulham Archives and Local History Centre, 191 Talgarth Road, London. W6 8BJ

He [aged 46] and his family were living at Sketty Road, Swansea, 1881 Census, his occupation described as Coal Exporter, see Census entry and other details following. In 1901 the family were at Ealing, London.

#### MINING

I think the source of the coal business was probably Llanilid, which was extensively mined - open cast. Extract from "A Topographical Dictionary of Wales' Samuel Lewis, 1833:

'The land is all enclosed, and by far the greatest part is in a state of good cultivation. Coal abounds in the parish, and in the northern part of it have been discovered some strata, which are about to be worked.'

The area appears now to have been restored, all looked green and very picturesque [apart from the wind farm on the hill] when I visited recently.

#### LOCATIONS

I have located Pant-y-Llwydd on map but Pant-y-Llwdd Fach no longer exists. TRALLWN is now the St. Mary Hill Golf Club and Hotel [Best Western] - I have taken some photographs, also of Llanilid Church.

And further to do, and receive in this behalf, as justice shall require under pain of the Law and contempt thereof. And what ye do in the premises do ye certify to us our Surrogate or other Competent Judge, in this behalf, together with these premises, at the time, and place, aforesaid. Given under the seal of our office this twenty eighth Day do December in the year of our Lord one thousand eight hundred and eleven.

I have enquired at Didmarton Parish web site as to the outcome, with no reply, but I think we can take it that the matter was sorted out, as Rev. Deere was still there at his death in 1821.

#### DAVID JONES OF WALLINGTON

I copied some notes at Cardiff Central Library some time ago, of correspondence between David Jones and a Charles Mason, who appears to have been interested in the DEERE and ROBERTS families and their possible connection. This is when I first became aware of the Tuck-Deere name. These as below, and I have drawn a copy of the Tuck-Deere arms which appear in the notes, and headstone inscriptions of the family of EDWARD DEERE of St. Athan, 1720's. From the dates and addresses, it is likely that Charles Mason had contact with the descendants of Rev. Morgan Deere in London.

#### EXTRACTS FROM DAVID JONES OF WALLINGTON'S NOTES ON THE DEERE AND ROBERTS FAMILIES OF ST. ATHAN [manuscript notebook at Cardiff Central Library]

The writing is not easy to read and I have indicated where I couldn't make it out.

It seems David Jones of Wallington was doing a bit of research on behalf of a CHARLES MASON who wrote to him from a number of addresses in the 1880s. The notebook is fragile and I was not allowed to photocopy, but I feel the original could be carefully photocopied and distributed, then put away somewhere safe.

'The Deere family of St. Athan had 27? [or 57] acres ..... of land in the Parish [St. Athan] in 1839, which was sold by Richard Deere to Mr. Rayer [father of Revd. Henry Rayer ....... who was rector of St. Athan, who died and is buried ..... 22 December 1853 aged 30]. *The Rayers bought large amounts of land in the area, which was sold 20thC.* 

He died ...... after he contracted typhoid fever at the Cowbridge Race Ball.'

David Jones then goes on to list entries from the Parish register, which from the notes appear to have been in a terrible state, with burials and baptisms mixed in together. Therefore I am noting only the very early ones which may not appear in the GFHS booklet, plus the children of Edward Deere who are named on the headstone drawn by David Jones.

#### DEERE BURIALS AT ST. ATHAN

David Jones has attempted to put together a few of the families, but I will omit this, as from what he says there may be errors, and it is unlikely to be as accurate as what we have today. He also lists Deere wills of St. Athan - Joan 1735 [admin], John 1768?, John 1736, Mathewsalem 1677, William 1740 [admin.]

There is a drawing of yet another version of the Deere coat of arms, with crest and motto, which I have drawn up. At least the colours agree with what we know - i.e., sa - sable - black, and ar = argent = silver. The coat of arms is divided into two, left and right, and the '3 bucks heads' which I would take to be the Deere's arms, are labelled as those of Tuck? [not easy to read], while the other half, consisting of 3 upturned crescents at the top half, with a chunky zig-zag in the bottom half, is labelled as Deere. The motto 'DDUW A DDIGON' I have seen on other local coats of arms and I think means 'God is sufficient' or similar. The crest is a stag complete with antlers, and again I think is not unusual in what I have seen of the local heraldry. However I have made enquiries in the past which have drawn a blank as far as an authenticated coat of arms for the Glamorgan Deeres is concerned, though I believe one is incuded in the Dynevor heraldic roll.

David Jones notes that the copy of the arms was "Given me by C. Mason Esq. 5 Dec. 1888".

# Letter from John Deer of St. Nicholas, Glamorgan to Howell Harris, preacher, [Calvinists]

#### february ye 2 1735

Mr. Harris I had ye pleasure last night to read Mr. Wittfilds Journal and the remarks upon it: and it surprises me very much to think how can any man be against it: for it seems to me that we have great reason to praise god for his mercy towards us in sending us such men in excellent spirit to unfold us ye mysteries of Religion: I mean ye Delivery of ?...... godliness: if we have not ye word we Perish for ye want of it: and if we have it we do perish doubly for the content of it: O that men would consider the terror of ye Lord and be persuaded and that they would learn so much wisdom not to aim the mercies of god against themselves: the word is given as a means to direct us in our way to happiness but he who stumbles and quarrels at ye means will fall short of it: from whom otherwise he might have been delivered.

I hope your last journey among us have left some impression upon ye hearts of a great many people. They do come daily to my house for if ye books that you promised to send down: our company do increase daily and we have our meetings at our house once if not twice a week: we do long for to see you among us and we pray to god that he would be pleased in his providence to direct you this way again: be so kind as to send ye books as soon as you can: John Yeoman is out of order or else he would come up with the carrier: we do long for to hear from Mr. Griffith Jones and to hear something about ye free school. Having no more to add but we do join all in our love to you which is all from your loving friend and servant.

*I have corrected* some of the spelling, but left in most of his punctuation, which consists of colons. John Deer was buried at St. Nicholas parish church 9 February 1743.

Pierce Cornish was one of the three children of William Cornish, a Cowbridge apothecary, and his wife Anne, nee Deere. His two sisters were Mary, who died young, and Ann, later named as a 'lunatic'.

Anne Deere had been involved in a breach of promise case at Llandaff Consistory Court, brought by the intended groom, Edward Powell of St Nicholas – that after kissing her passionately in public she had failed to turn up at the church on the day arranged. She stated to the court that her mother and friends had prevented her from attending. Anne was in fact a wealthy woman, and so it has been suggested that Powell was a fortune hunter and was stalled by Anne's family.

The Deere family had lived in Llanquian Isaf in Aberthin; Anne's father was Pierce Deere, a Cowbridge shopkeeper and alderman, who had married Mary Aubrey, daughter of Richard Aubrey, a Cowbridge mercer. The marriage settlement for this and earlier marriages brought a considerable amount of property to the family; Mary Deere(Aubrey)'s marriage to Dr James Allen of Gileston, after the death of her first husband, Pierce Deere, was another source of wealth.

Succession through the Aubrey line went to Mary Aubrey's niece, who in 1723 died childless, separated from her husband Edward Portrey of Boverton – and her property went to Pierce Cornish. Both his parents died by 1726; by 1744 Pierce was Deputy Lieutenant of Glamorgan, and a man of some property. He died in 1756, unmarried and with a rather complicated will, which had to be sorted out in the Court of Chancery. His heir, John Willson, a Bath saddler, was declared bankrupt in 1767, leading to further problems, with all of the estate having to be sold.

The Cornish/Aubrey/Deere papers contain a great deal of information about the transactions.

DEERE FAMILY

A distant cousin and myself are still ploughing on with our research on the family and have studied quite a few more wills. Among the copies obtained by my cousin are some Chancery wills for Rev. John Deere, Susanna Deere [sister of Hester Salmon] Penlline Court, and a couple of wills for the Trallwn branch, Llanilid. A few bits of interest to yourself, and we intend to write up some notes for depositing with Glam FHS eventually.

**Rev. John Deere's** will was made in 1765, and the Royal Oak [left to him by his uncle John Deere of St. Mary Church] he left to his nephew Edward Thomas, a son of his late sister, Joan. The Royal Oak at the time was occupied by a John Thomas, possibly another relative, though this is not stated.

Rev. Morgan Deere of Trallwn, Llanilid branch [proved 1823]. We have amassed quite a bit of information on this branch, down to 20th century, and including one of Rev. Morgan Deere's sons, Richard Tuck Deere. He was of Wiltshire when his name appeared in Glamorgan Electoral Rolls 1845 and his descendants were later of Swansea 1881 and Kensington.

Another of Rev. Morgan Deere's sons was John Morgan Rudolphe Deere, solicitor of Cowbridge at the time of his father's death. John M. R. appears to have been buried at Clifton in 1843. I have some details of an affray/GBH case he was involved in, as the accused!

I will send you a copy of our work when completed, and in meantime send you notes on some 'Cuckoo Mill Strays' connected with the Cowbridge area.

### DEERES - CUCKOO MILL STRAYS

WILLIAM DEERE - baptised 8 May 1785 Penmark on the same day as Evan following.

- William, the son of Morgan Deere 1st and his first wife Catherine, died in 1822 aged 37 and was buried at Penmark from Hensol [which is in the Pendoylan / Ystradowen area].
  A William Deere of Pendoylan appears in the Militia Lists for 1820, 21, Cowbridge Hundred.
- Ystradowen a bastardy case 1805 for the child of Elizabeth John of Ystradowen, The father was named as William Dear, miller, of Pendoylan. He probably lived at Warren Mill, Pendoylan. Glam RO think this may have been part of the Aubrey estate at that time. ¥ To

The Parish Register Ystradowen confirms baptism 22 September 1805, aged 19 days, of William the son of William and Elizabeth Deere, but makes no mention of illegitimacy, so perhaps they married, though two further illegitimate children were born to an Elizabeth John 1808 and 1812, not fathered by William Deere.

Then we have a William Deere of Pendoylan married Elizabeth Claxson in 1810 at St. Nicholas Parish Church.

 The little boy baptised in 1805 Ystradowen went on to marry and have a family of his own. William Deere married Catherine Howell at Llanblethian 1830, both of parish.

From the 1851 census she was born in Llanblethian, but her age doesn't tally with 1841, and there is a baptism for Catherine, 4 days old, daughter of Edward and Jane Howell of Llanblethian August 17 1806, which fits in with the 1851 census.

WILLIAM DEERE married CATHERINE HOWELL 4/08/1830 Bachelor and spinster. Bride, Groom and witnesses all signed with X. Witnesses - David and Jane Howell

Baptised at Llansannor in 1834 two sons of William and Catherine Deere [Edward and William]. William was a labourer living at Trebettyn, Llansannor.

Son Edward was at Maesmafan farm, valleys, aged 17 and a servant, born Llanblethian.

Son Morgan was Twyn-y-Garth, valleys, aged 10, a servant, born Llanwonno.

**EVAN DEERE -** Baptised Penmark 8 May 1785, the illegitimate son of John Deere by Mary Williams. [William [1] above, son of Margan and Catherine, was baptised on the same day]

1. This raises the question of which John Deere was his father, as the old man [John Deere Jnr.] was still alive at this time, and a widower. I have not established whether his eldest son John had survived, or was buried at St. Nicholas in 1743. At any rate, the child was given the Christian name of a deceased son of John Deere Jnr. and wife Mary, who had died in 1763. (EURN)

Evan seems to have been in Pendoylan with William [1] above in the 1820s, as he also appears in the Militia List, and married there 1816.:

EVAN DEERE married JUAN MORGAN 25/05/1816 BP Both signed with marks, Evan with 3 vertical lines crossed through horizontally. Witnesses - Anne Phillips and Mary George

2. This couple had a child baptised at Llanblethian as follows:

Mary Deere, daughter of Evan, a miller, and Juan, baptised 19 March 1817.

Possibly Juan died in 1817 as a Joan Deere was buried there 12 July.

No further entries at Llanblethian for them, and I cannot find them in Glamorgan 1841

Thre was a Mary, niece, at Cuckoo Mill in the later censuses, said to have been born Cowbridge c. 1821, but this age does not fit this daughter of Evan and Juan. In case you don't have it I enclose Margery's will. It is interesting that she left Crossways [which was mortgaged] to her son John. As you can see there were disputes following the will, but from other sources it seems Crossways went to t Bassetts via Rev. Henry Jones, husband of a Mary Deere, who seems to have t rather disreputable, if this is the same man mentioned by William Thomas and H M. Thomas in her St. Hilary book!

I also have a transcript copy [sent by another researcher] of the Canterbury will Humphrey Deere of Faversham, Kent, 1771, a son of Margery and her husband Edward. Humphrey's son Edward must be the man mentioned later in the John Diaries in connection with property at Llanblethian.

John, son of Margery, may be the man who married Mary Rees nee Curre, widc but I've not looked into this.

An Isaac Redwood, Feltmaker of Cowbridge, is mentioned as appra: witness ref. admin. of William Deere of St. Athan 1740. I have discovered some of my family [John and Robert Deer[e], b: of our ancestor Morgan Deere, at Llanelli 1760s onwards, supporters of Wesley, who visited them and preached on one occasion from their doorste result, I borrowed a book on Wesley's visits to Wales, and find stoned by people of Cowbridge on an early visit, but later had a better reception there. There is also mention of John Deer of St. Nicholas, Calvinist e:

#### WILL OF MARGERY DEERE OF CROSSWAYS LLANBLETHIAN 1782 - LL/1782/35 Daughter of Edward Deere The Elder of Rhoose [will 1723] and Gt. Granddaughter of William [1677]

Margery married EDWARD DEERE of Crossways, son of Edward [Will 1727 above]. She was sister to Mathew Deere of Ash Hall [Will 1770] which her descendants inherited from Mathew.

Also I give and Devise unto John Franklen of Llanmihangle in the said County Esquire and my Son in Law the Reverend William Church of Bampton near Whitney in the County of Oxford, Clerk and to the Survivor of them and the Heirs Executors and Administrators of such Survivor All and singular my full Moiety or equal part or share [into two equal parts to be Divided] of all and singular the Freehold Customary hold and Copyhold Messuages Lands Tenements and Hereditaments whatsoever with their and every of their Appurtenances situate lying and being in the County of Glamorgan in as large and ample manner as the same lately Descended and came to Me as co-heir with my Nephew Mathew Percival, to my late Brother Mathew Deere Esquire Deceased and all my Estate Right and Title thereto to have and to hold all and singular my said full Moiety or equal part or share of the said Messuages Lands tenements and Hereditaments with their and every of their Appurtenances unto the said John Franklen and William Church their Heirs and Assigns to such uses and upon such Trusts and to and for such Intents and purposes as are herein after by me mentioned and expressed of and concerning the same, that is to say, that they the said John Franklen and William Church or the Survivor of them and their Heirs Executors or Administrators of such Survivor shall and Do with all convenient speed after my Decease by Sale of my said Moiety of the said Messuages Lands Tenements and Hereditaments so to them Divided as aforesaid and out of the monies arising from such Sale [after payment of such Incumbrances affecting the same) pay and satisfy all the several Legacies and Bequests by me herein after given and Bequested at the several and respective times herein after by me Limited and Appointed for payment thereof [that is to say]

I Give and Bequeath unto my Daughter Posthuma Deere the sum of Eight Hundred Pounds. I also Give and Bequeath unto my Daughter Elizabeth Deere the sun of Four Hundred Pounds

I also Give and Bequeath unto my Grandson Edward Deere the sum of Two Hundred Pounds. I also Give and Bequeath unto my Grand Daughter Catherine Deere the sum of Two Hundred Pounds I also Give and Bequeath unto my Grand Daughter Mary Deere the sum of Three Hundred Pounds, being the three children of my late Son Humphrey Deere Deceased.

I also Give and Bequeath unto **my Grandson Douglas Church** and **my Grand Daughter Catherine Church**, two of the Children of the said William Church by **my Daughter Catherine** the sum of One Hundred Pounds each.

All which said Legacies and Bequests I hereby Order and Direct to be paid the several and respective Legatees above named by the said John Franklen and William Church and the Survivor of them and the Executors and Administrators of such Survivor out of the monies arising from the Sale of Moiety of the said last mentioned Messuages Lands tenements and Hereditaments so to them Divided In Trust as aforesaid, within three months next after such Sale shall be perfected,

And my further Will is, that in Case the money arising from such Sale to my said Moiety of the said Messuages Lands tenements and Hereditaments shall prove insufficient [after the payment of the Incumbrances affecting the same] to Answer and pay the several Legatees above named their respective full Legacies at the time and in the manner herein before Directed and Appointed for payment thereof as aforesaid **then** and in which Case but not otherwise I do hereby Order Direct and Appoint that such Deficiency so Happening from the Sale of my said Moiety of the said estate Shall be Borne Sustained and Allowed by all and every of the said legatees and that in equal proportions of their respective Legacies any thing in this my Will contained to the contrary Notwithstanding **and** my further Will and meaning is that my said trustees their Executors and Administrators and every of the Rents and Profits of my said Moiety of the said Moiety and saved harmless from all Costs Charges Troubles Expenses and Damages which shall or may happen to them by reason of this Trust or anything relating thereto by and out of the Rents and Profits of my said Moiety of the said Messuages Lands tenements and Hereditaments so to them Devised In Trust as aforesaid and that each of them his Heirs Executors and Administrators bee Answerable for his own receipt Act and Deed and not for the receipt Act or Deed of the other of them and his Executors and Administrators.

And further I Give and bequeath unto my said daughter Posthuma Deere all and singular my Goods Chattles and Personal Estate of what kind or nature soever it be, subject to the payment of my just debts and funeral Expenses.

And I doe hereby Nominate and Appoint my said Daughter Posthuma Deere Sole Executrix of this my last Will and Testament hereby revoking all former Wills by Me heretofore made and Declaring this to be my last.

In witness whereof I the above named Margery Deere have to this my last Will and Testament Set me Hand and Seal this Thirteenth Day of September in the year of our Lord One Thousand Seven Hundred and Eighty One.

Margery Deere signed her name.

Witnesses, all signed: Ann Lewis, Thos. Lewis Junr., Thos. Lewis

Unfortunately **Posthuma [Deere] Griffiths**, wife of Jenkin Griffiths died in her mother's lifetime. There are several further sheets attached to the will, but the gist of it is that Elizabeth Deere, Catherine and William Church, John Walters of Llandough-j-Cowbridge and John Franklen are all named in administration documents dated 24th June 1782, Llandaff, with Elizabeth and Catherine stating that Margery's goods chattles and credits amounted to less than One Hundred Pounds. Elizabeth and Catherine were granted administration.

There was a **Chancery case** dated 3rd November 1784 between Anne Bassett, widow, and others [Complaintans], and Mathew Deere Percival and others [Defendants] as follows:

At the Examination of Witnesses, at the Execution of a Commission in this case, the paper writing marked with the letter **I** [the admin. page] was produced and shown to Ann Lewis and Thomas Lewis, and by them severally Deposed, unto the fourth Interrogatory on the behalf of the Complainants by and before us [signed by Will: Rees and Tho: Thomas]

Attached to a copy of the will, there is a further [deleted] passage dated 20th November 1785 mentioning a dispute between Anne Bassett, widow, and other complainants, and Mathew Deere Percival and other defendants,

Then another [undeleted] passage on the same page, and dated 25th March 1790 confirming receipt of the original will, as follows:

Received March 25th 1790 of Mr. Edw. Pearson Regr. of the Consistory Court of Landaff the Original Will of Mrs. Margery Deere late of the parish of Lanblethian in the County of Glamorgan Widow, and of which the foregoing is a true copy in order to be attended with at the **assizes** to be held at Cardiff on the said 25th day of March Instant which I promise to return fair and unaltered.

The same from Complainants and Defendants as above.

Signed Thos. James
