Letters from Ann Thomas, Hill House to Mrs Jones of Bath 1831-6

Oct 1831 (777) - re Mrs Jones's property in the house -

Had a mare purchased for my own riding at St Mary Hill fair yesterday. I rode upwards of 10 miles. My youngest niece Susanna accompanied me on the ride. Can you do me a favour of saying the exact sum Col Entisle was to pay you (re 16 shillings paid at Bath).

The garden at Crossways has been very productive of fruit. I have had a dozen and a half fine peaches from there, upward 1000 taken off green from the trees.

1833, 14th December (778) Miss Entwisle unwell - under Dr Nicholl's

Vandalism in the village - Revd R Knight had a .... Stole out of his garden that had been there ever since they lived there and some wall broken down, the top stones of the pillars of my iron gate taken down and the top of the Mount served the same. Mr Entwisle called on me. I begged him to go to Molly Lloyd that keeps the public house by the church and enquire who were there on Saturday night. Thomas Jones eldest son Eaton (?) Williams the mason and Rowlands and son such other....... Mr Entwisle observed to me this work had been before this 3 weeks about that time Will Jones came home. Till then the village had been quiet.

1835, January (779) - mentions her son 'Charles will be 3 next May' (b May 1832)

1836, January (780) Molly Dawkin and Wm Williams (as tenants of Mrs Jones) to have two and sixpence each. Thos Jones has had the flannel for his shirts which I fear you will think dear flannels are high now. Mention of Philip David's rent.

1836, Jan Rumour is very busy in marrying Mrs Howels to the clergyman of this parish — she is looking very well and gay. I saw my neighbour Mr Entwisle on horseback this morning going with a gentleman hunting, Mrs Entwisle is so so, Miss E never better.

1836, May (181) Cowbridge has had many of its inhabitants removed this spring. Keys among the number and many children from that scourge the scarlet fever.

My house is full of workmen painting and papering. The walls had gone so shabby.

Philip David goes to Coal (sic) either to Bridgend or Crack, you may recall a small public house just on the side of the road on the Golden Mile now coal is brought there from the trams (? trains) that come to Bridgend that in three hours we can have coal brought to the house.

1836, 4th August - 782

 $5 \, \mathrm{th}$  Oct 1836 (783) On above coal from within the Golden Mile or Ewenny where there are coal yards. The proprietors of those yards fetching it from the trams at Bridgend in waggons.

Mrs Powell is enabled to ride out in her Phaeton whenever weather will prevail......strong enough to walk across her drawing room without a stick.

1836, 21st November (784)

1837, 29th March (785)

Eliza Bates now Mrs Wm Edmondes was at church today for the first time since her marriage. They have taken on a small house in the village near his grandmother's. There is but one sentiment she will have the worst of it

The vicarage of Cowbridge is given to the Dean of Gloucester nephew Revd Thos Edmondes he and friends are in hopes to get an exchange for his living in Cambridge then Mr Edmondes will be enabled to live with his friends. Some say to be married to the widow Mrs Howels, whoever has him I think will have a very worthy man. Some say she has rejected him, has been with her brother N Wales since the autumn.

1837, 2nd Dec (787) Rents received from Mr Llewellin & Phillip David
