Will of Griffith Gybbon of Prisk, gentleman, 11th November, 1712

In the Name of God Amen the eleventh day of November in the yeare of our Lord God one thousand seaven hundred and twelve and in the Eleventh yeare of the Reign of our Sovereign Lady Anne by grace of God of England Scotland France & Ireland etc. Queen I Griffith Gybbon of Prisk in the parish of Welsh St Donats in the County of Glamorgan gent[leman] being sick in body but of good and perfect Memory (thanks be to Almighty God) and calling to remembrance the uncertainty of death, Doe make constitute ordaine and declare this my last will and testament in manner and forme following Revokeing and disannulling by these presents all and every testament & testaments will and wills heretofore by me made and declared wither by word or writeing and this to be taken onely for my Last will and Testament and none other

ffirst I doe commit my soul to Almighty God my Saviour & Redeemer in whome and by the merits of Jesus Christ I trust & believe assuredly to be saved and have full remission and forgiveness of all my sins and my body to be buried in my wifes grave in the parish Church by my Executor hereafter named,

And now for settling of my temporall Estate & such goods & Chatles as it hath pleased God to bestow upon me I doe order give and dispose of the same in manner & forme following (that is to say)

Impri[mis] I give devise & bequeath unto my s[econ]d son Griffith Gybbon four pieces of old Gold called Jacobus pieces to be paid within one whole yeare nextafter my decease by my Executor hereafter named, as alsoe I give devise & bequeath unto him the said Griffith the Lease called Tay Hirion now in the possession of one Robert Thomas In case that after my decease it may happen that my sonne Jenkin Gybbon burying his now wife Catherine and marrying another woman that then and from that day the said Lease of Lands is to be and Enure to him the said Griffith Gybbon his Executors and assigns during the ffull tearme of the said Lease

It[e]m I give devise and bequeath unto my Grand=daughter Wenllian Gybbon the full summe of one hundred pounds of lawfull British money to be paid her within one whole year next after my decease by my Executor hereafter named

It[e]m I give devise and bequeath unto my Grand=daughter Anne Gybbon the summe of one hundred pounds of lawfull British money to be paid unto her within three yeares next after my decease by my Executor hereafter named

It[e]m I give & bequeath twenty shillings sterling to be laid out by my Executor within one whole year after my decease for & towards the use of the poore of the parish of Welsh St Donats the use of the said twenty shillings to the s[ai]d poore for ever

It[e]m I give and bequeath unto Mary David my servant Provided she serves me until my decease the sume of twenty shillings sterling to be paid her within one whole yeare after my decease by my Executor

It[e]m give and bequeath unto my Cozen David Gybbon one coat vest and breeches in token of my love to him

It[e]m I doe hereby give devise and bequeath all the rest of my goods catle and Chatles moveable and immoveable not before given and bequeathed unto my dear son Jenkin Gybbon whome I doe hereby nominate and appoint to be my sole and only Executor of this my last will and Testament In Wittness whereof I have hereunto put my hand and seale the day month and yeare first above written / the Marke of Griffith [his mark] Gybbon

Administration Bond: Evan Lewis: 24th January, 1765

In the Consistory Court of Llandaff, 24th January, 1765, administration of the goods etc. of Evan Lewis, deceased, was granted to his widow, Friswith Lewis. Friswith Lewis, George Bassett, taylor, and Robert Bassett, labourer, all of the parish of Welsh St Donats, were bound by the Court in the sum of £400 for Friswith Lewis to make and exhibit a true inventory of the goods etc. of her late husband at or before the 30th April next; to administer according to law; to give a true account of her administration at or before the 31st January, 1766; and to present to the Court any last will and testament of the deceased that might appear. All three boundens recorded their mark on the administration bond.

First I give and Bequeath unto my Sister Jane Morgan my Best Gown and Best Quilt petty Cote Best hat and shoes & silk Clock

Itt[em] I give and Bequeath unto my Natural Daughter Mary my Flanan gown and Cotton petty Cote and one pare of Shose and likewise I doe give and Bequeath unto my s[ai]d Daughter Mary the sum of Eight pounds to be paid her when she arrived to the age of one and Twenty years by my Executors hereafter named and the s[ai]d Eight pounds is to be in the custody of William Thomas of the Parish ystra Doven or his Executors until such time

And all the Rest of my Residue of my worly goods both Real and Personal that I shall be owner of or Intitled unto the time of my Decease I give and Bequeath the same to my Dearly beloved

Children Juan Lewis, Cissil Lewis and Jane Lewis and I doe and appoint Robert Basset of the Parish of Welsh St Donats and Wenllian Thomas of the Parish of Lancarvan wid[ow] to be joint Trustees and Gardians over my s[ai]d Daughters until they attain the age of one and Twenty years, and whereas Sixty Pounds that is in the hand of the afores[ai]d William Thomasis to be in his Custody or possession until the s[ai]d Juan Lewis, Cissil Lewis and Jane Lewis until they come to the age of one and Twenty Excepted the Interest for their Maintenance of the s[ai]d Juan, Cissil and Jane, and the afores[ai]d Trust[ee]s & Guardians Robert Basset and Wenllian have no Power to Rise the afores[ai]d sixty Pounds from the Possession of the s[ai]d William Thos. nor his Executors Except the Interest during the time of the afores[ai]d ages
 And also further Nominate and appoint the s[ai]d Robert Basset and Wenllian Thomas to be Joynt Executors and trust of this my Will for the use of my s[ai]d Daughters Juan, Cissil and Jane until they attain the age of one and twenty years In Witness whereof I have hereunto set my hand and Seale the twenty third day of December one thousand Seven hundred sixty and five

Will of Thomas Donne, 5th June, 1847

This is the last Will and Testament of me Thomas Donne, of Welsh St Donats, in the County of Glamorgan. Made the Fifth day of June, in the year of Our Lord, One Thousand eight hundred and forty seven

Whereas I the said Thomas Donne am possessed of certain Freehold, Leasehold, and Copyhold estates in the town of St. Albans, in the County of Hertford, I hereby give, devise, and bequeath , unto my dear Wife Emma Crawley Donne, her heirs, executors, administrators, or assigns each, and every the whole of the said estates, whether Freehold, Leasehold, or Copyhold, together and individually, and also all appurtenances belonging thereto and all the rights and privileges, whatsoever for her sole, separate, and absolute use, and disposal free from all costs, and charges whatsoever.

And I hereby also give, devise, and bequeath, all my personal property, consisting of all my money or monies whether funded or otherwise, together with all Books, papers, plate, linen, furniture, and stock of cattle, and implements, on the farms rented by me, in the said parish of Welsh Saint Donnatts, in the county of Glamorgan and all debts due to my estate, or which may hitherto become due, and all and every benefit or interest to which my estate is now, or may hereafter become entitled to, together with all residue whatsoever whether real or personal, unto and for the sole and separate use and benefit of my said Wife Emma Crawley Donne, subject only to the payment of all my debts, and funeral and testamentary expenses, and also to the sum or legacy of £100 One hundred pounds, of lawful money of Great Brittain, which legacy I give and bequeath to my Brother William Donne. though the said legacy is not to become due or payable, or in any way chargeable to my estate during the lifetime of my Wife. And it is further my wish, that all residue of my personal estate, whatever remaining, after the decease of my Wife E. C. Donne, may be divided equally between my daughter Mary Anne Donne, and her child or children then living, share and share alike subject. to all just debts, and funeral, and testamentary expenses of my said wife Emma Crawley Donne

And I hereby constitute and appoint my said Wife Emma Crawley Donne, and my said Brother William Donne, my executrix, and executor, of this my last Will and Testament. In witness whereof, I the said Thomas Donne, do hereunto set my hadn and seal, the day and year first above written

In the Consistory Court of Llandaff, 4th December, 1847, William Donne of Moulton in the parish of Monknash, brother of Thomas Donne, who died on the 10th June, 1847, made oath that the goods etc. of his late brother are under the value of £1,500, power being reserved for making a like grant to Emma Crawley Donne, relict and executrix, before Richard Prichard, surrogate.
